Distinguished Partners in Excellence Award

The State Board of Community Colleges is currently accepting nominations for the **2024 Distinguished Partners in Excellence Award** through October 13, 2023. This award recognizes exemplary employers, businesses or industry groups that have demonstrated decisive involvement and firm commitment to the professional development of its employees and/or to the development of North Carolina's workforce through its partnership efforts with one or more of the 58 community colleges in the North Carolina Community College System.

Background

The Distinguished Partners in Excellence Award was created by the State Board in 2006 to honor a company, business or industry group and its community college partner(s) whose joint efforts have resulted in significant benefits to the professional development of its employees, or individuals pursuing job training/retraining for future employment

and/or

Honor a company, business or industry group and its community college partner(s), with the result of that collaborative effort creating significant benefits to the community or to regional/state economic development.

Nomination Process

The Awards Committee of the State Board of Community Colleges suggests that colleges use the nominating form to discuss and explore the unique nature of the partnership between their college and the business or organization whose name is herein placed in nomination, keeping in mind that there are likely other community colleges that may have similar partnerships with organizations in their communities. A person or group may submit only one nominee. The nomination must be signed and endorsed by the president of the community college.

<u>Eligibility</u>

This year, the State Board is celebrating the significant impact and growth of Workforce Development on the North Carolina Community College System by striving to recognize a business in <u>each of our six</u> <u>trustee regions</u>. Businesses or industry groups so honored will be invited to the annual event to accept the award in the spring of 2024.

If a nominated business is affiliated with any member of the Awards Committee, said member(s) will recuse themselves for this specific selection process. The Chair of the State Board of Community Colleges will assign replacement board members to the Committee if needed. Previous business award winners are ineligible.

Selection Criteria – Demonstration or examples of:

1. Award nominees must have demonstrated a concern for advanced education relative to economic and workforce development in the community, as well as education training and services.

- 2. Financial support of a community college or program may be considered as one criterion for selection. However, it is only one of many variables that the Awards Committee will take note of.
- 3. Successful nominees must demonstrate an active partner relationship between the company and the community college(s). There must be evidence of a firm commitment on the part of the business/partnership to community colleges and of a firm commitment by the community college(s) to the business/partnership.
- 4. The Awards Committee will look closely for nominations that include novel, innovative, and creative ways of addressing a community's challenges in economic and workforce development, as well as education training and services.
- 5. Awards are presented to businesses/partnerships and their community college allies, not to individuals.

Acceptance of an award constitutes a commitment on the part of a senior executive of the business to be present to receive the award.
